Background

- 1. GHG emissions and energy consumption for all Flagstar property assets included via either consumption obtained from utility invoices or estimated using industry best practice. Please note, the data reported above only includes Flagstar's leased and owned properties and does not include data related to the recent merger of New York Community Bank and acquisition of Signature Bank.
- 2. Natural gas and electricity consumption estimated for properties not included in ENERGY STAR Portfolio Manager using CBECS Building Electricity energy intensity factors from EIA. Estimations are based on square footage and total months the property was identified as in operation during the reporting year.
- 3. Property asset square footage (area) used to calculate the Scope 1 and Scope 2 (location-based) emissions intensities is the sum of gross floor area for buildings that are within Flagstar's control boundary, not under construction, and owned in that reporting year. This means properties within Flagstar's operational control boundary and considered stable or in lease-/fill-up for the reporting year are included.
- 4. Scope 3 emissions (CO₂ only) are representative of Flagstar's business travel (Scope 3, Category 6), accounting for emissions from hotel stays, air travel, and train travel.
- 5. Water consumption tracked (from utility invoices) or estimated (see note 6) for only properties contained within Portfolio Manager. No estimate of water consumption for non-Portfolio Manager properties performed.
- 6. For Portfolio Manager properties with water consumption missing, water consumption is estimated with the following order of preference 1) average of known water consumption per size for said property 2) average of known water consumption per FTE for said property 3) average annual water consumption per size all properties and 4) average annual water consumption per FTE for said property 3 average annual water consumption per size all properties.
